Information we collect

We may collect the following information:

- Name(s)
- Invoicing addresses
- Delivery addresses
- Office addresses
- Email addresses
- Phone numbers
- Fax numbers
- Purchase / order history
- Bank account number
- Bank account sort code
- Bank card details

How we use the information we collect

We may use your information to:

- Process orders
- Provide customer service
- Arrange the delivery or provision of goods or services
- Notify you of changes / progress to orders
- Verify your identity
- Send you information or documentation that you have requested
- Make payments to you
- With permission, take payments from you for orders that you have placed
- Investigate and respond to any complaints made
- Ensure business policies are adhered to
- From time to time, we may use your information to contact you for market research purposes

What if I don't provide some or all of the information requested?

The impact of this will depend on what information you withhold, but the main impacts may be:

- We will not be able to process or fully process an order
- We will not be able to contact you and let you know of any issues with an order
- We will not be able to respond fully to requests or queries

What grounds (legal basis) are we processing the data under?

We process data for several reasons / obligations. These are;

- Contractual We need the information to perform the contract for goods or services ordered/requested including payment, delivery etc.
- Legal Should we be legally required to contact you concerning a purchase or service etc.
- Legitimate interest Meaning that processing is in the interest of Chiltern Building Products Ltd. This allows us to manage the customer/supplier relationship effectively and efficiently and improve the goods and/or services we provide by better understanding how our provisions are used and other market research in our interest.
- Consent Where you have given us consent to contact you etc.

Sale of the Business

In the event that we undergo re-organisation or are sold to a third party, information that we hold about you may be transferred to that re-organised entity or third party.

How we protect your data

We follow strict procedures to ensure that your information is storage in a safe way to prevent unauthorised access to, and loss misuse or alteration of your personal information in accordance with UK data protection legislation.

Your rights regarding your personal information

If you are a resident of the European Economic Area, you have the following data protection rights:

- Correcting your information

You are entitled to have your personal information updated to ensure it is up to date and accurate. In order to change any personal information, you should contact our Data Protection Officer (contact details outlined above in 'about us' section).

- Obtaining a copy of your information

You have the right to receive a copy of the personal information that we hold of yours. You can obtain this by contacting out Data Protection Officer (contact details outlined above in 'about us' section).

Deleting your information

You can request that we delete your personal information in certain circumstances. These will be specific to each case. You can do this by contacting our Data Protection Officer (contact details outlined above in 'about us' section). Please note that some personal information may need to be kept for legal reasons, in this situation you will be informed.

- Withdrawing consent

You have the right to withdraw your consent to any processing that is being done under your consent. This includes any marketing To withdraw your consent, you must contact our Data Protection Officer (contact details outlined above in 'about us' section).

Data Portability

You have the right to request that your data be given to another controller.

Restricting processing

You can request a restriction on the processing of your data, however this can only be done in some limited circumstances. For example, if you are concerned over the accuracy of the data that we hold on you or we no longer need to hold your data, but you have requested us to keep it for you to aid you in a legal matter. You can do this by contacting our Data Protection Officer (contact details outlined above in 'about us' section).

- Right to object to processing

You have the right to request that we stop processing your data for marketing purposes as well as other limited circumstances. For example, the processing of your data by completely automated means or to not analyse your information for targeted content etc. You can do this by contacting our Data Protection Officer (contact details outlined above in 'about us' section).

Chiltern Building Products Ltd. have no current need or future plans to transfer your data to a third country or recipient outside of the European Economic Area. If this changes at any point in the future, this policy shall be updated and state:

- If the recipient of your data is covered by a commission adequacy decision
- Details of the safeguards put in place to ensure the security of your personal data or the risks that the transfer of your data brings.

Rights of complaint to the Regulator for Data Protection

The data protection laws in the UK are regulated and enforced by the Information Commissioner's Office (ICO).
